**Team Rosters –**

**U-9 -no guest players - Format – 11 v 11 -** Teams that played U-9 in the Spring will play U-9 in the Puma Cup as they do not change their age distinction until August, after this tournament.

**NOTE: There will not be an U-10 Academy Division as those players became eligible to play U-11 Competitive on July 1.**

U-11 through U-15 – 18 players, up to 5 guest players

U-17 through U-19 – 22 players, up to 5 guest players
